<u>3.7</u>: To encourage women to form self help group and impart training and knowledge to weaker sections of the society so that they learn basic hygiene, family planning, thrift, savings, so that they become independent wage earners.

<u>3.8</u>: To institute, establish libraries and book banks at rented premises, and provide facilities for deserving stugents to buy books at concessional rate or free of cost.

<u>3.9</u>: To plan, promote and assit programmed financially for agricultural development, animal husbandry, supply, storage and marketing agri products which will make the beneficiary improve their living standard.

<u>3.10</u>: The Trustees may spend on such other objects which are in general, charitable in Nature or in public interest with in the meaning of the provisions of Indian Income tax Act 1961. The objects mentioned are independent of each other and the Board of Trustees may from time to time apply the funds of the Trust in carrying out all or any of the afore said objects of the Trust as it may deem fit, proper and necessary. The Trust may acquire or dispose off by purchase or sale by gift, settlement or otherwise any movable or immovable asset for the furtherance of the objects of the Trust.

- 4) <u>Beneficiaries</u>: The beneficiaries of the Trust shall be the need, men and women, differentially abled persons, and individual who need aid, succor and upliftment without any distinction of caste, color, creed, gender and religion.
- 5) <u>Trust Fund</u>: Income from agricultural lands, rent from Buildings, gifts, interest on deposits, contributions received from the Trustees and the General Public, Financial assistance received from Government and other institutions and other receipts considered as income will form funds which are to be utilized for the promotion of the objects the Trust. The surplus may be invested in any securities authorized under section 20 of the Indian Trust Act and subject to the provisions contained in section 13 (1) (d) R/W 11 (5) of the Indian Income tax Act 1961. The Income accumulated in any year shall be invested in the above said manner by virtue of the provision of section 11 (2)of the Income Tax Act.

Any Trustee who is found to act against the interest of the Trust or derogatory to the dignity of the Trust can be removed after issuing a show cause notice by <sup>3</sup>/<sub>4</sub> member of the Trust.

Any of the Trustees shall cease to be a Trustee ;

- 1) If he/she resigns from the Trusteeship.
- 2) If he/she is removed as mentioned above in para 7.
- 3) If he/she is convicted for any criminal offence.
- 4) If he/she is of unsound mind.
- 5) If he/she is declared an insolvent.
- 8) <u>Liabilities of the Trustees</u>: If any one of the Trustees breach the Trust and thus brings loss to the Trust fund or properties, he is liable to make good such losses, which the Trust property or beneficiary has suffered and he shall be liable to such losses and shall be reimbursed by him.

- 9) Powers of the officers of the Board of Trustees :
  - a) <u>Chairman :</u> The Chairman shall be the executive head of the Trust. His advice shall be final in all matters pertaining to the administration of the Trust. He shall preside over all meeting and conduct them in a democratic manner. He shall have the powers with the consent of the Board of Trustees , employ staff, agents, Bankers, Lawyers , Accountants and Auditors and other such persons as are need to administer the Trust smoothly at such remuneration as the Board authorizes. He may delegate his powers to such Trustees whom he thinks fit for that purpose. In the absence of the chairman the Vice Chairman may perform all or any of these duties mentioned above. The Chairman shall be the custodian of all the Trust properties.
  - b) <u>Secretary</u>: He shall in consultation with the Chairman fix the date and venue of the meeting, prepare the agenda and send notices to all the Trustees of the Board well in advance. He shall carryout the resolution passed at the meetings of the Board and report it to them at the next meeting. He shall enter into correspondence with others. He shall initiate legal action against others and defend the Trust on all legal matters by employing proper lawyers. He shall authorize the Treasurer payments to be made. He shall be assisted by the Joint secretary in the discharge of the duties.

- <u>c)</u> <u>C) Treasurer:</u> He shall be the incharge of all accounts and receipts and payments of the Trust. He shall deposit monies received in the designated banks keeping Rs.10,000/- as impressed cash. He shall prepare periodic receipts and payments of the Trust, present it before the meeting of the Board of Trustees and get their approval. He shall operate the Bank accounts jointly authorized by the Board either with the Chairman or Secretary. He shall have the annual accounts audited and get it approved by the General Body of the Trust.
- <u>d)</u> <u>d) Executive Committee:</u> They shall participate in all meetings and deliberations and offer their considered opinion all matters that come up for discussion at the meeting of the Board of Trustees.
- 10. <u>General:</u> All decision of the Board shall be passed either unanimously or by a simple majority. In case of "Tie" the Chairman shall have a casting vote. The quorum for the Meeting of the Board shall be four Trustees.
- 11. <u>Meeting of the Trust</u>: The Chairman of the Board of Trustees shall preside over the Meetings of the Board of Trustees and the General Body of this Trust. In his absence the Vice chairman shall preside over the meetings. In the event of non availability of both of them any senior member present may be asked to Chair the meeting and conduct the proceedings. The meeting of the Board of Trustees shall be as often as necessary for the smooth running of the affairs of the Trust.

The General Body of the Trust shall meet at least once in a year, within 3 months of the closing of the annual accounts in each financial year (i.e.,)31<sup>st</sup> day of March of each year. The secretary shall send notice to all the Trustees 21 days in advance with the copy of the audited accounts with the agenda. The General Body shall, approve the accounts presented and the program and activities of the Trust. The General Body shall appoint qualified Chartered Accountants to audit the accounts of the Trust and if need can elect new officers for the Board to fill up vacancies if any. No object of the Trust shall be amended, altered or deleted without the prior permission of the commissioner of Income Tax. Such amendments if permitted shall be passed by 2/3<sup>rds</sup> majority of the Trustees.

- 12. <u>Borrowings:</u> For the growth and expansion of the charitable activities of the Trust the Board of Trustees are empowered to borrow money from Banks, Financial Institutions, Private Parties, Government Agencies by offering the properties of Trust as securities and execute necessary deeds, bonds, mortgages, for this purpose. The Chairman of the Board of Trustees as the Chief Executive officer of the Trust shall execute the financial documents on behalf of the Trust. All the Trustees are jointly and severally responsible in the due discharge of the liabilities incurred by the Board of Trustees.
- 13. <u>Accounts & Audit</u>: The accounting year of the Trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> day of March of each succeeding calendar year. The Board shall be responsible for maintaining proper books of accounts with respect to all receipts and payments, income and expenditure with bills and vouchers. A Chartered Accountant shall audit the accounts which shall be presented at the Annual General Body Meeting of the Trust
- 14. <u>Area of Operation:</u> The activities of the Trust shall be within the Indian Republic and not outside India.
- 15. <u>Remuneration or Monetary Benefit</u>: None of the Trustees of this Trust shall be entitled to any remuneration or monetary benefit in whatever name called. However the Trustees shall be entitled to reimbursement of all expenses incurred by them including travelling expenses for the purpose of this Trust or attending any official meetings. They shall also be indemnified in respect of all acts done in the course of discharge of their duties. The Trustees are NOT entitled to any remuneration.
- 16. <u>Public Trust</u>: This is a registered public charitable Trust and is irrevocable. If at any time the object of the Trust should become impossible for fulfillment of the properties and funds belonging to this Trust shall be transferred to any charitable Trust with similar objects. The Benefit of this Trust shall be open to all without any distinction of caste creed religion or sex. The properties shall not revert to the founders.
- 17. <u>Power to Modify</u>: The Board of Trustees reserve the power to modify or alter this deed so as to bring out the intention should the same has not been expressed clearly and correctly in these presents. Before making any amendments /alternatives to the Trust deed, necessary approval has to be obtained from the commission of Income Tax in whole jurisdiction this Trust lies.
